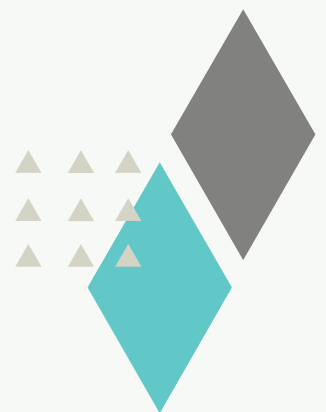
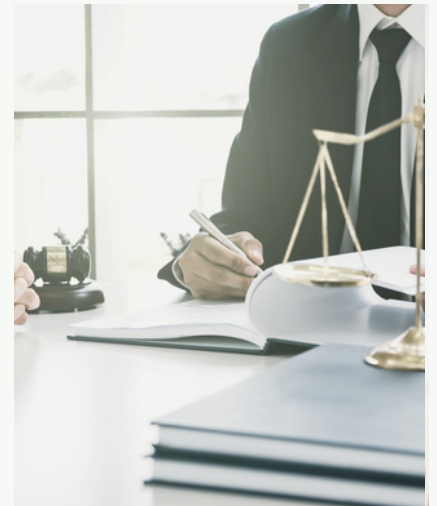
### Language

### 1. CV/Resume

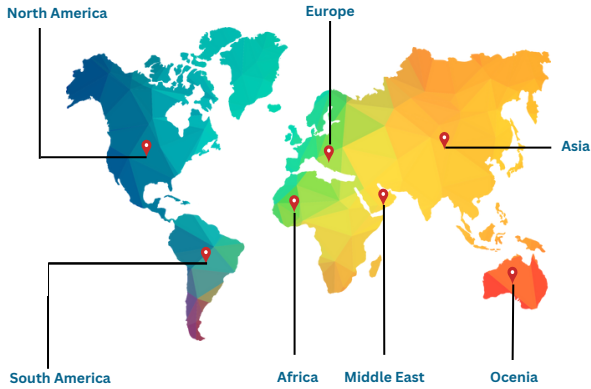
- CV/Resume should be precise.
